Commissioner Mark motioned to approve the agenda, as presented, seconded by Commissioner Liner and approved unanimously.

#### PUBLIC HEARING – RESOLUTION IN SUPPORT OF PARTISAN

At 7:02 p.m. Commissioner Mark motioned to open the Public Hearing, seconded by Commissioner Mitchell and approved unanimously.

Chairman Jones reviewed for the record that the notice for the Public Hearing allowed for emails to be submitted until noon, April 5, 2021. There were 80 emails received in support of the Resolution and 47 received in opposition. These will be entered into the Minutes as public records. (Addendum A at the back of the Minutes)

Mr. Jones stated to conduct the Public Hearing in an orderly fashion, Ms. Frances Boomer, Chairman of the School Board of Education would speak on their behalf first and would have three minutes. He indicated a coin toss had been held before the meeting, between Bob Brinson with the Republic party and Nancy Allen with the Democratic party, with Ms. Allen winning the toss to go first. He stated they both will receive eight minutes.

Mr. Jones informed the group that each person who signed up to speak will be given three minutes and will alternate between those in support and those in opposition. While everyone who wants to speak will be given the opportunity, Mr. Jones indicated they could pass if they felt like they had nothing new to add to the issue, and their name would still be entered in support or opposition in the Minutes.

At 9:19 p.m., Commissioner Liner motioned to open the Public Hearing on the Animal Control Ordinance Amendment. Commissioner Mitchell seconded and the motion was approved unanimously.

Clerk Nan Holton read the proposed Amendment to the Animal Control Ordinance.

**Justification:** The Sheriff's Office received a donation check from Linda Smith to help with the purchase of Honor Guard Equipment, which will be used by the Honor Guard for ceremonial purposes only.

### DISCUSSION OF RESOLUTION IN SUPPORT OF BOARD OF EDUCATION ELECTIONS

Commissioner Mitchell thanked the citizens who both spoke and emailed on the topic and expressed appreciation to all the educators given the difficulty of the past year. She stated that we all want what is best for our children and how to educate them, but just have different approaches on how to do that. Ms. Mitchell said she supported the voting by District concept. She highlighted that the issue is not about the educational system nor the teachers; it is about the School Board. Ms. Mitchell reported that the Board of Commissioners have been inundated with letters, emails, and phone calls from parents wanting the school system open and that the School Board has not been responsive nor held accountable. Ms. Mitchell concluded by saying she would vote in favor of the Resolution.

Commissioner Smith stated she is strongly opposed to the Resolution, as she believes schools should be non-partisan. Ms. Smith relayed that the information she heard in support of the proposed resolution at a previous work session astonished her, as it was full of misinformation. She indicated as a former School Board member, her truths are different from what she has heard as reasons to be in support of the resolution. Ms. Smith set about to rebuke some of the misinformation that had been presented.

In regards to the School Board's actions not being available to the public, she stated that everything they do is public knowledge and done in open session, except for personnel issues; and that all their records are available by asking or online. She highlighted that at all of their meetings, there is a teacher, a parent, and a principal present.

Ms. Smith reported that the School Board meetings are held the third Thursday of each month, with a work session on the Tuesday prior to the meeting; all are held at the central service office and published in the paper and online. She further declared that if a person wants information on candidates it is readily available online and from the Board of Elections office; and if the incumbent is not being accountable to the citizen, then they do not have to vote for them.

Referencing the Hatch Act and its restrictions on Federal employees, she indicated people should conduct their own investigation into the facts and not just follow others blindly.

Ms. Smith then addressed the undervote used to support reasoning to make the School Board partisan by providing statistics from the Board of Commissioners elections in 2018 and indicated the results do not validate the undervote.

She continued by countering statements about the loss of students and double tuition by highlighting all the variables involved that result in student population decreases: redistricting, decreases in classroom sizes, loss of choice of schools, Hurricane Florence, and the pandemic. Ms. Smith reported that when your child leaves the public school system, which is a mandatory service considered essential to our country, the money follows the child, so a parent is not paying tuition twice. Schools are funded by taxes and what a school receives is based upon their enrollment.

Commissioner Smith concluded by stating it is wrong to deceive others with information that is not carefully researched and factual. She stated this is my truth and I support non-partisan Board of Education elections because it supports every person being allowed to campaign and hold office if they choose. She indicated it is important to her because there was a time when she and people like her, were left out for reasons that were not Christian.

At this time, Commissioner Mitchell requested to call the question. Commissioner Mark seconded and her motion was approved in a 5-2 (Nays – McCabe, Smith) roll call vote.

Commissioner Mark motioned to adopt the following Resolution in Support of Partisan Board of Education Elections. His motion was seconded by Commissioner Mitchell and carried in a 5-2 (Nays: McCabe, Smith) roll call vote.

# CRAVEN COUNTY BOARD OF COMMISSIONERS RESOLUTION SUPPORTING THE IDENTIFICATION OF PARTY AFFILIATION OF EACH CANDIDATE FOR CRAVEN COUNTY BOARD OF EDUCATION AND SUPPORTING THE ELECTION OF SUCH MEMBERS BY DISTRICT

**WHEREAS,** members of the Craven County Board of Education are elected in non- partisan elections; and,

**WHEREAS,** Craven County Board of Education members are not elected purely by district but rather run by district in primaries and county-wide in general elections; and,

**WHEREAS,** identification of candidates' party affiliation will provide voters with more information about the positions and policies the candidates support; and,

**WHEREAS**, twenty-six (26) school districts in North Carolina currently elect their Board of Education members in partisan races.

**THEREFORE, BE IT RESOLVED,** that the Craven County Board of Commissioners requests the North Carolina General Assembly establish that henceforth the party affiliation of candidates for the Craven County Board of Education be identified and that members of the Craven County Board of Education shall be elected solely by district; and,

**FURTHER RESOLVED,** that the election of members of the Craven County Board of Education occur in even years; and,

**FURTHER RESOLVED,** that this change in the election of Craven County Board of Education members shall not impact the terms of any current members of the Craven County Board of Education; and,

**NOW, THEREFORE, BE IT RESOLVED,** that the Craven County Board of Commissioners respectfully requests that this change begin in the next election cycle, 2022.

#### DISCUSSION OF ANIMAL CONTROL ORDINANCE AMENDMENT

Chairman Jones requested that the vote on the Animal Control Ordinance Amendment be deferred, as that is typical protocol on ordinance amendments.

Commissioner McCabe motioned to defer the vote until the April 19, 2021 meeting. His motion was seconded by Commissioner Mark and approved unanimously.

At 10:00 p.m. a five-minute break was taken.

# DEPARTMENTAL MATTERS: SOCIAL SERVICES – SELECTION OF CONTRACTOR FOR THE ADMINISTRATION OF CHILD SUPPORT ENFORCEMENT SERVICES

Social Services Director, Geoffrey Marett, reported that in the May 18, 2020 meeting of the County Board of Commissioners it was approved to enact the option of a one year extension that was included in the original contract. The current one year extension will end on June 30, 2021. He stated that on January 4, 2021 a Request for Proposals was posted on the Craven County website in order to solicit proposals to administer the Child Support Enforcement Program in Craven County. On February 24, 2021 three proposals were received.

These proposals were rated by a review panel that consisted of Geoffrey Marett, Social Services

Director, April Rollins, Income Maintenance Administrator with Craven County DSS and Gene Hodges, Assistant County Manager. References for the selected provider were contacted by Mr. Marett. Mr. Marett relayed that Young Williams' knowledge and experience with similar projects, in addition to cost, put them in the best position to help Craven County continue in the administration of the Child Support Enforcement program and the next step will be entering into a contract with Young Williams to administer these services beginning July 1, 2021.

Commissioner Mark motioned to select Young Williams as the company to administer the Child Support Enforcement program in Craven County and (i) authorize the Social Services Director and person selected by the County Manager to prepare a contract to serve the purposes and needs as presented/discussed and (ii) authorize the Chairman, Vice-Chairman, Manager and Clerk to execute and deliver the contract once prepared, and any other ancillary documents which may be required to fully implement the contract. His motion was seconded by Commissioner Mitchell and in a roll call vote approved 7-0.

#### DEPARTMENTAL MATTERS: HEALTH - ADDITIONAL COVID FUNDING

Health Director, Scott Harrelson, reported that additional state funding has been awarded to the Craven County Health Department to assist with COVID-19 vaccination planning & implementation of mass COVID-19 vaccination. He stated funds will be used to support and strengthen immunization planning and implementation requirements and activities to ensure effective, efficient, and equitable vaccination of the statewide population, equipping health care providers to discuss the vaccine and administer it to patients, ensuring adequate clinic staff availability, and ensuring systems can track vaccines administered and provide recall tracking and notification to complete vaccine series.

Mr. Harrelson requested approval of a budget amendment in the amount of \$284,327.00.

Commissioner Mark motioned to approve the following budget amendment, as requested, seconded by Commissioner Liner and approved 7-0 in a roll call vote.

Mr. Harrelson provided a brief Covid 19 update stating that transmission in Craven County is currently 12 cases per 100,000 a day. Craven County vaccinations are higher than the State averages and continues to move along successfully.

#### DEPARTMENTAL MATTERS: CDBG-NR CONTRACT AWARD

Planning Director, Don Baumgardner, reported that a re-bid opening for the rehabilitation & elevation of (1) storm-damaged, owner-occupied home included in the CDBG-NR Program was held on March 25, 2021. Bid proposals were received from two contractors: Gilbert Everett Builder, Inc. and Paul Woolard Construction.

Mr. Baumgardner highlighted that the proposed contract award is within program budget; therefore, prompt approval of this contract award is requested to move forward with assistance with this household.

Commissioner Mark motioned to approve the low bid award to Gilbert Everett Builder, Inc. for \$138,000.00, as requested, seconded by Commissioner Mitchell and approved unanimously.

#### DEPARTMENTAL MATTERS: FINANCE – STATE REVOLVING LOAN FUND

Finance Director, Craig Warren, relayed that at the November 16, 2020 Board of Commissioner's Work Session, County staff along with staff from McKim & Creed, presented a project to Commissioners to replace and upgrade sections of the water system's telemetry components that were damaged during Hurricane Florence. As part of the presentation, engineering cost estimates, along with several funding options, were discussed and considered. The Board authorized County staff to begin the process of submitting a funding application to the Division of Water Infrastructure's State Revolving loan program to finance this project. Mr. Warren stated that the application period to request funding is now open and runs through April 30, 2021. The adoption of a resolution is required in order to move forward with the application process.

Commissioner Mark motioned to adopt the following resolution, as requested, seconded by Commissioner Smith and unanimously carried.

### RESOLUTION BY CRAVEN COUNTY BOARD OF COMMISSIONERS

**WHEREAS**, The Federal Clean Water Act Amendments of 1987 and the North Carolina the Water Infrastructure Act of 2005 (NCGS 159G) have authorized the making of loans and grants to aid eligible units of government in financing the cost of construction of SCADA and Telemetry for existing drinking water distribution system, and

**WHEREAS**, The Craven County Government has need for and intends to construct a SCADA and Telemetry improvements project described as installation of fiber optic and communications equipment, and

**WHEREAS**, The Craven County Government intends to request state loan assistance for the project,

### NOW THEREFORE BE IT RESOLVED, BY THE CRAVEN COUNTY BOARD OF COMMISSIONERS OF THE CRAVEN COUNTY GOVERNMENT:

That Craven County Government, the **Applicant**, will arrange financing for all remaining costs of the project, if approved for a State loan award.

That the **Applicant** will adopt and place into effect on or before completion of the project a schedule of fees and charges and other available funds which will provide adequate funds for proper operation, maintenance, and administration of the system and the repayment of all principal and interest on the debt.

That the governing body of the **Applicant** agrees to include in the loan agreement a provision authorizing the State Treasurer, upon failure of the Craven County Government to make scheduled repayment of the loan, to withhold from the Craven County Government any State funds that would otherwise be distributed to the local government unit in an amount sufficient to pay all sums then due and payable to the State as a repayment of the loan.

That the **Applicant** will provide for efficient operation and maintenance of the project on completion of construction thereof. That <u>Craig Warren</u>, <u>Finance Director and Jack B. Veit, III, County Manager</u>, as the **Authorized Officials**, and successors so titled, is hereby authorized to execute and file an application on behalf of the **Applicant** with the State of North Carolina for a loan to aid in the construction of the project described above.

That the **Authorized Official**, and successors so titled, is hereby authorized and directed to furnish such information as the appropriate State agency may request in connection with such application or the project: to make the assurances as contained above; and to execute such other documents as may be required in connection with the application.

That the **Applicant** has substantially complied or will substantially comply with all Federal, State, and local laws, rules, regulations, and ordinances applicable to the project and to Federal and State grants and loans pertaining thereto.
